**The mission of Construction Workers Christian Fellowship is to**

1. **assist** Christian organizations in the spreading of the Gospel of Jesus Christ through specialized construction help, at home and abroad;
2. **encourage** and mentor Christians in (and into) the construction trades, to excel as craftsmen and to bring the redeeming influence of godly lives and a Christian world view into the workplace;
3. **tell** construction workers about the saving power of Jesus Christ, that they may experience a changed life.

**Our Statement of Faith:**

We believe that the Bible, consisting of Old and New Testaments only, is verbally inspired by the Holy Spirit, is inerrant in the original manuscripts, and is the infallible and authoritative Word of God.

1. We believe that the one triune God exists eternally in three persons, Father, Son, and Holy Spirit.
2. We believe that Adam, created in the image of God was tempted by Satan, the god of this world, and fell. Because of Adam's sin all men have guilt imputed, are totally depraved, and need to be regenerated by the Holy Spirit for salvation.
3. We believe that Jesus Christ is God, was born of a virgin, died vicariously, shed His blood as man's substitutionary sacrifice, rose bodily, and ascended to heaven where He is presently exalted at the Father's right hand.
4. We believe that salvation consists in the remission of sins, the imputation of Christ's righteousness, and the gift of eternal life received by faith alone, apart from works.
5. We believe that the return of Jesus Christ is imminent, and that it will be visible and personal.
6. We believe that the saved will be raised to everlasting life and blessedness in heaven, and that the unsaved will be raised to everlasting and conscious punishment in hell.
7. We believe that the Church, the Body of Christ, consists only of those who are born again, who are baptized by the Holy Spirit into Christ at the time of regeneration, for whom He now makes intercession in heaven and for whom He will come again.
8. We believe that Christ commanded the church to go into all the world and preach the Gospel to every creature, baptizing and teaching those who believe.

- ❖ We value Godly character. With consistent integrity, our words and actions can be trusted.
- ❖ We value people. Each one is unique, loved by God and of incalculable worth.

## Code of Christian Conduct

CWCf is a Christian organization. All CWCf Associates, missionaries, and employees, by virtue of their participation and/or employment with CWCf, are engaged in Christian ministry. Under the 1972 Amendment to the Civil Rights Act, CWCf, as a religious organization, is permitted to use its religious doctrines and practices as a basis for hiring and other employment decisions. Therefore, being a Christian and sharing and complying with CWCf's religious principles are key requirements for all CWCf employees, missionaries, Associates, and Board members.

Evidence of an individual's Christian conversion and commitment must include behaving in a Christ-like manner and refraining from engaging in any activity or behavior that is condemned by Scripture or that would otherwise bring disrepute upon the name of Christ.

In order for CWCf's Christian mission to be effective, CWCf's associates, missionaries, and employees must live and project a Christian lifestyle in both their professional and private lives. All CWCf associates, missionaries, and employees should strive to live holy lives, in accordance with the demands of Scripture.

It should also be understood that, because belief and lifestyle issues cannot be exhaustively or comprehensively stated, CWCf shall be the sole judge, as it has understood the Word of God, of whether an employee's conduct violates CWCf's religious principles and lifestyle expectations.
